### Conditions/Terms of the Sale

Seller guarantees that this kitten is healthy to the best of their knowledge. This kitten is guaranteed for 72 hours against, but not limited to the following ailments: upper respiratory infection, internal and external parasites, and FELV/FIV.

Seller agrees that they are the owner and has good and lawful authority to sell the above described kitten/cat. Buyer has 72 hours to take the kitten to the vet (at buyer’s expense) for a health exam, if any health concerns are found, the buyer may return kitten to the seller within 72 hours with an explanation from the attending vet stating why the cat’s health is in question. No medical, travel charges or other expenses will be refunded.

During this first 72 hours the kitten should be isolated from any other pets and monitored for health, eating, litter box usage and activity level.

The seller is not responsible for any injury or illness to other pets or this kitten caused by exposure. This includes FIP/FCoV. Under no circumstances will this cat or kitten be sold, leased or given away to any pet store, research laboratory, breeding mill or similar facility. Seller must be notified if cat is to be resold or given away. Seller retains the right to have the first option of re-adoption in the event a home can no longer be provided.

This cat or kitten will be kept indoors and not be allowed to roam freely outdoors. If cat is found to be neglected or mistreated, purchaser will surrender cat to Seller unconditionally, with no refund or reimbursement.

If this kitten was purchased whole, it is agreed that the kitten will be altered before the age of 7 months. With proof of altering sent to the seller. Seller will then issue registration papers within 90 days. If this kitten was purchased altered, then registration papers will be sent within 90 days of the sale.

It is recommended that this kitten not be declawed.
